The positions that will be up for election is the Vice President, Treasurer, Chairman of the Board, and (3) Board Members.

In accordance with Chapter Rules Version 1.2, Any Chapter member in good standing wishing to run for the office of President, or Chairman of the Board, must first have held another office, i.e.: Treasure, Secretary, or Board member, for a full term with RTIN Chapter #1.

# Chapter Vice President Duties and Responsibilities Description

The Chapter Vice President is an elected official with a (2) year term. The Chapter Vice President enhances the organization's public standing by clearly articulating the Rolling Thunder mission statement, accomplishments, and goals to the public and garners support from the community.

The duties of the Chapter Vice President will include, but not limited to the following duties.

- a. Reports to the Chapter President.
- b. Takes over the Chapter President's duties in his/her absence.
- c. Assist the Chapter President in the daily operation of the Chapter.
- d. Attend all monthly Chapter meetings.
- e. Assist the Chapter President to make sure all members follow the Rolling Thunder® National Constitution.
- f. Performs any other task assigned by the Chapter President.
- g. Manages new membership applications.
- h. Recommends programs to the Chapter Board, and membership on promoting new membership.
- i. Must not miss (3) consecutive meetings without legitimate excuse submitted to the Chapter President.
- j. Must abide by the Rolling Thunder® National Constitution Rules of Conduct at all times.

# Chapter Treasurer **Duties and Responsibilities Description**

The Chapter Treasurer is an elected official with a (2) year term. He/she maintains custody of all the Chapter funds, and securities and will keep a full and accurate account of all receipts and disbursements in a ledger. The Chapter Treasurer enhances the organization's public standing by clearly articulating the Rolling Thunder® mission statement, accomplishments, and goals to the public and garners support from the community.

The duties of the Chapter Treasurer will include, but not limited to the following duties.

- a. Disbursement of the funds of the Chapter as directed by the Board of Director after approved by the Board of Directors and/or Membership in accordance with the Chapter rules, and will comply with the Rolling Thunder® National Constitution.
- b. Maintains full accountability of all finances, to include the reconciliation of all Chapter bank accounts (General Operating Account, Gaming, and PayPal).
- c. Maintains comprehensive documented audit trail: receipts etc. of all accounts receivable and payable.
- d. Assist in the preparation of annual financial report.
- e. Provides monthly financial report to the Chapter.
- f. Collects and deposits annual membership dues, patch deposits, and other funds received by the Chapter.
- g. Prepare financial analytical reports as needed for the Officers and Board of Directors.
- h. Prepare an annual budget of revenues and expenses for Board of Directors and Membership approval.
- i. Prepare Federal and State tax returns.
- j. Obtain raffle licenses from the Gaming Commission and prepare event reports and annual reports. Prepare and submit lease contracts for events supporting raffle ticket sales.
- k. Must have business background and experience, and/or education in finance and accounting. Comfortable in the use of the computer for email, internet, and accounting software.
- 1. Must abide by the Rolling Thunder® National Constitution Rules of Conduct at all times.
- m. Must not miss (3) consecutive meetings without legitimate excuse submitted to the Chapter President.

### Master Sergeant Wallace Simmons Korean War MIA Identified June 20, 2024

Name: Wallace Simmons Jr

From: Marion County, Indiana

The Battle of Chosin Reservoir, also known as the Chosin Reservoir Campaign was a decisive battle in the Korean War. On 27 November, the Chinese Army surprised UN Forces at the Chosin Reservoir area. A brutal 17-day battle in freezing weather and rough terrain soon followed. In the period between 27 November and 13 December 1950, 30,000 United Nations troops were encircled and attacked by approximately 120,000 Chinese troops.

The cold weather was accompanied by frozen ground, resulting in frostbite casualties, icy roads, and weapon malfunctions. In the end over 17,000 UN forces were killed or wounded or missing in action, or died of wounds. The Chinese suffered 3 times that amount.

Master Sergeant Simmons is the third Indiana Service Member that has been identified from the Chosin Reservoir battle.

#### **Challenge Coin**

While there are several stories as to its origin, one thing that is undeniable is that they started in the military.

In the Roman Empire, the ancient Rome Empire dating to 27 BC to the modern Roman Empire collapsing in 476 AD it is said that Roman soldiers that excelled in battle, would receive their typical day's wages along with a separate bonus coin. Those coins might have been specially minted featuring the marks of the legions from which they came. Those coins were cherished and not spent, just as the challenge coin is today, cherished and kept.

During the Renaissance (14<sup>th</sup> through the 17<sup>th</sup> century) there was a coin known as 'Portrait Medals' that were used to commemorate specific events.

The first instance of using a coin as a response to an actual challenge may come from the 17th century religious wars in France. French Protestants suffered persecution by the Sate for their illegal religion. While many Protestants fled France, those that stayed carried a méreau (meal-ho) communion coin. The coin was used to gain entry to the Protestant church and distinguished them from a spy.

Yet another story, the challenge coin originated during WWI. It is an interesting story that involved a pilot being shot down, captured by the Germans who took all of his personal identification except the bronze medallion that a wealthy lieutenant had ordered and presented to his unit. Then escaping, donning civilian clothes, and making his way to the front line and through no-man's land into friendly forces, it was the medallion that was recognized saving him from being accused and executed as a saboteur.

Today we see Challenge Coins for U.S. Presidents, NASCAR, NFL, police and fire departments, motorcycle clubs, and the list goes on and on.

Getting your hands on a challenge coin these days might feel like you're part of a covert operation, often passed through a secret handshake. While it's not a hard and fast rule, this subtle exchange adds a layer of mystique to the tradition.

Rule for Challenging. There are many......and may vary depending on the organization. The act of challenging is called a 'coin check' and is usually loudly announced. The challenge is the most common way to ensure that members are carrying their unit's coin.

The challenge can be made at any time. The challenger drawing his/her coin and slapping or placing the coin on the table or bar. In the noisy environment it could be the tapping or rapping the coin on a surface to initiate the challenge. Accidentally dropping a challenge coin is considered to be a deliberate challenge to all present.

Everyone being challenged must immediately produce the coin for their organization and anyone failing to do so must buy a round of drinks for the challenger and everyone else who has their challenge coin. However, should everyone challenged, produce their coin, the challenger must buy a round of drinks for the group.

While most holders of challenge coins usually carry them in their pockets or in some other readily accessible place on their persons, most versions of the rules permit a challenged person 'a step and a reach' or if an individual has an extra coin to pass it off the person closest to them. However, a coin worn on a belt buckle or key chain are not acceptable for meeting the challenge, as the coin would need to be defaced in some fashion.

Our quartermaster (Spark Plug) has our own Chapter challenge coin available for you. If you don't have yours, you may be buying.




# Indiana POW/MIA Specialty Plates on the Streets As of May 31, 2024



As of May, 2024, we have **4,879** POW/MIA specialty plates on the streets of Indiana helping to bring awareness to the public about our POWs, and MIAs. The funds generated from the sale of the POW/MIA Specialty plate goes towards helping our Indiana Veterans in need through the Indiana Military Family Relief Fund (MFRF). **We are 39 plates up from this time last year**.

Please Note: The June plate sales will be announced at the July Chapter Meeting.

#### **Indiana POW/MIA Specialty Plate Fund**



Since the introduction of the Indiana POW/MIA Specialty Plate in January 2010, the plate has generated an estimated \$1,353.650 100% of the proceeds generated from the sales of the POW/MIA specialty plate goes to the Indiana Military Family Relief Fund (MFRF) to help our Indiana Veterans in need.

If you don't have a Indiana POW/MIA Specialty Plate on your vehicle, please let the Bureau Motor Vehicle (BMV) know that you would like to purchase a Rolling Thunder® sponsored POW/MIA specialty plate on your next renewal or new purchase.

With the purchase of a Indiana POW/MIA specialty plate, not only will you be instrumental in helping to bring awareness to the public about our POWs and MIAs, you will be helping our Indiana Veterans in need.

# Rolling Thunder®, Inc. Membership Patches and Obligations National Constitution

The Rolling Thunder® patches are items that members strive to obtain. The Boot patch represents the members Chapter, and the Rocker and Eagle represents Rolling Thunder® National. These patches should be worn proudly and with respect. When a member is issued these patches, they have an obligation to take care of them and turn them in if they decide to quit Rolling Thunder® for whatever reason. Below is an abstract from the National Constitution on the members obligations that they agree to when they receive these patches.



The Chapter Boot Patch. All members will receive a Rolling Thunder® Membership Boot patch when they become a full member at the end of a 120-day period. If a member meets his/her obligations before the 120 days are up they are entitled to receive their Boot patch no earlier than 90 days, provided they meet all other (loyalty and conduct) requirements. A new member must make 3 meetings or events, or a combination thereof, during the 120-day trial period to become a full member. A \$50.00 patch deposit is required before National will issue the Boot Patch.



The Rocker and Eagle Patches. After a member completes his/her first year (from the day they receive their boot patch) as a member in good standing ,they will be issued the Eagle & Rocker patches, which is the property of National. A \$100.00 patch deposit is required before National will issue the Rocker and Eagle Patches.

## **Membership Obligations**

**Retrieve Patches**: It's the Chapters responsibility to retrieve all patches. If a member does not renew dues in a reasonable time, thirty days from the end of February the Chapter President or his appointed representative will collect their patches. Any Chapter that does not retrieve the members patches will be held liable for their cost. Any problems from a delinquent member to collect our property, if needed have a lawyer send a letter and take them to court (quote the constitution) that a member will pay all court and lawyers fees. The Chapter will pay National \$150.00 per set lost and members deposit will not be refunded.

If you mail your patches to the Chapter, make sure you send the package **CERTIFIED** or **PRIORITY** mail for tracking purposes and insure the package for \$150.00.

Please DO NOT Glue your patches on your vest. National will NOT accept damaged patches and you may lose your patch refund.


