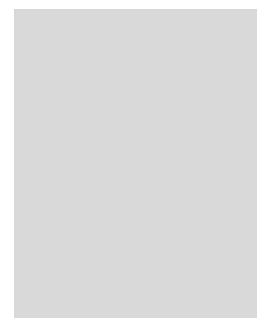

Chapter Treasurer

Duties and Responsibilities Description

The Chapter Treasurer is an elected official with a (2) year term. He/she maintains custody of all the Chapter funds, and securities and will keep a full and accurate account of all receipts and disbursements in a ledger. The Chapter Treasurer enhances the organization's public standing by clearly articulating the Rolling Thunder® mission statement, accomplishments, and goals to the public and garners support from the community.

The duties of the Chapter Treasurer will include, but not limited to the following duties.

- a. Disbursement of the funds of the Chapter as directed by the Board of Director after approved by the Board of Directors and/or Membership in accordance with the Chapter rules, and will comply with the Rolling Thunder® National Constitution.
- b. Maintains full accountability of all finances, to include the reconciliation of all Chapter bank accounts (General Operating Account, Gaming, and PayPal).
- c. Maintains comprehensive documented audit trail: receipts etc. of all accounts receivable and payable.
- d. Assist in the preparation of annual financial report.
- e. Provides monthly financial report to the Chapter.
- f. Collects and deposits annual membership dues, patch deposits, and other funds received by the Chapter.
- g. Prepare financial analytical reports as needed for the Officers and Board of Directors.
- h. Prepare an annual budget of revenues and expenses for Board of Directors and Membership approval.
- i. Prepare Federal and State tax returns.
- j. Obtain raffle licenses from the Gaming Commission and prepare event reports and annual reports. Prepare and submit lease contracts for events supporting raffle ticket sales.
- k. Must have business background and experience, and/or education in finance and accounting. Comfortable in the use of the computer for email, internet, and accounting software.
- l. Must abide by the Rolling Thunder® National Constitution Rules of Conduct at all times.
- m. Must not miss (3) consecutive meetings without legitimate excuse submitted to the Chapter President.

Chapter Chairman of the Board Duties and Responsibilities Description

Armed Forces Day at the Track May 17th—19th

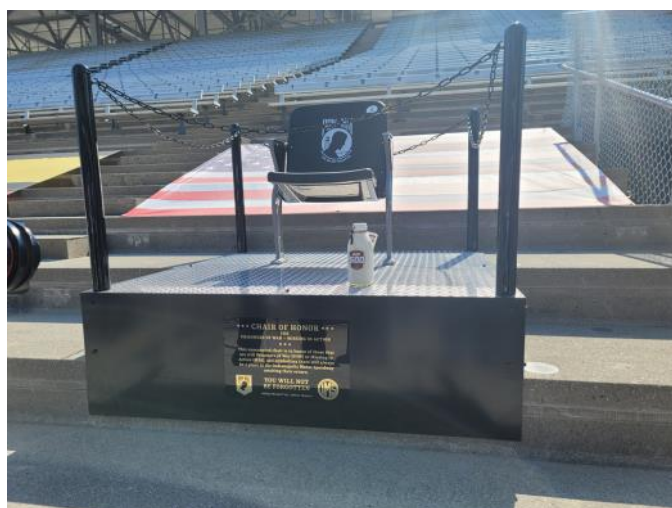

The 36th Ride for Freedom is in the books. This year, we rode again to the Veterans National Memorial Shrine and Museum in Fort Wayne Indiana. The staff at the memorial provided outstanding support to the Chapter and we really appreciated their support. They have a great facility.

We started out with registration at the Fort Harrison Veterans Center and rode to the Fort Wayne Harley Davidson shop to pickup the Fort Wayne riders that registered at the shop on the morning of the event. We had a total of **50** that registered at the Fort Harrison Veterans Center and **15** that registered at the Fort Wayne Harley Davidson shop. Out of the **65** that registered, **15** were FNG's.

Chapter members read the names, performed the Roll Call ceremony, and placed Dog Tags on the wreath for the Service Members from WWII and the Korean War that are still missing from Allen County. Allen County currently has 40 MIAs from WWII and 10 from the Koreans War.

The Chapter also performed the Roll Call ceremony, and placed Dog Tags on the wreath for the 50 Vietnam War MIAs from Indiana. During the Roll Call ceremony, Captain Phillip Alan Ducat's name was called and his Biography was read by the Chapter President. Captain Phillip Alan Ducat is the only Vietnam War MIA from Allen County.

After the Roll Call ceremony for our Vietnam War MIAs, the Chapter President mentioned the number of Americans that served during Global War on Terrorism and the number American Casualties to include nine from Allen County. The names of the nine Service Members from Allen County were read.

As a tribute to the brave men and women who gave their lives for the freedoms that we enjoy today, the American Legion Post 241 fired a three Volley salute followed by TAPS.

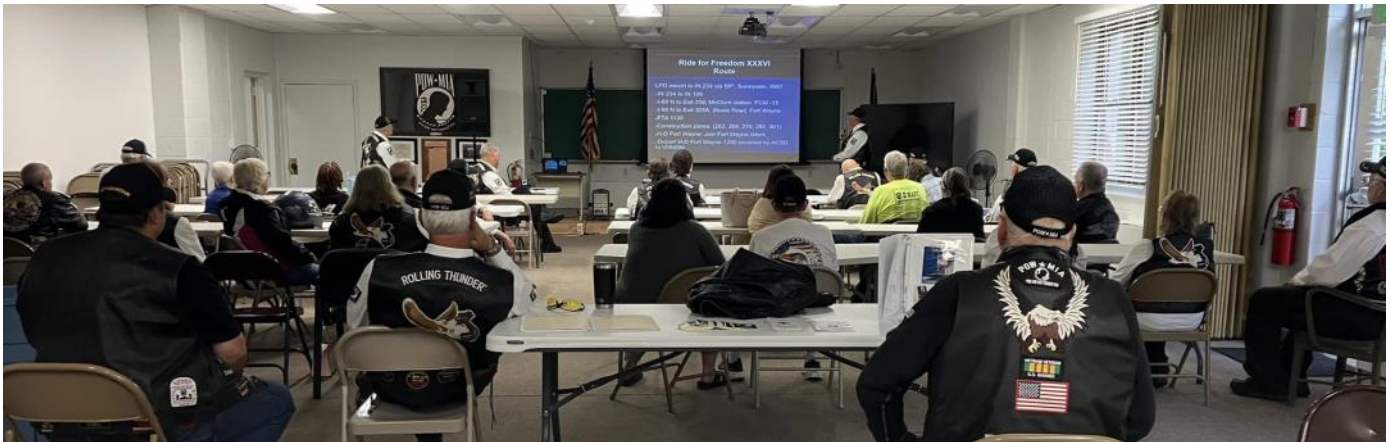

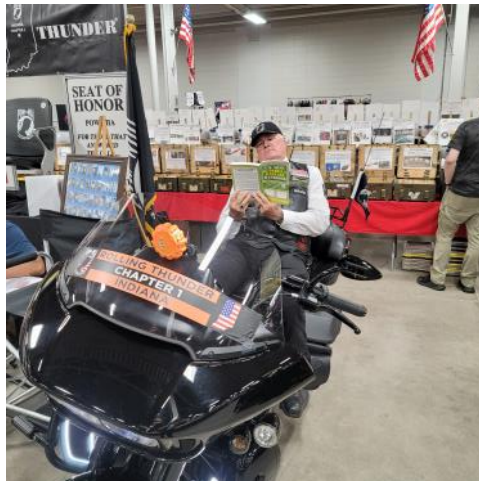

WWII MIA
PVT Harold Oscar Poulter Escort
Friday May 31, 2024



On January 17, 2024, the Defense POW/MIA Accounting Agency (DPAA) identified the remains of Private Harold Oscar Poulter, missing from World War II. Private Poulter entered the U.S. Army in Ohio and served in Company G, 2nd Battalion, 318th Infantry Regiment, 80th Infantry Division. On February 7, 1945, this division crossed the Sauer River into Germany and began to assault enemy positions on the east bank. The next day, Pvt Poulter's 2nd Battalion advanced north through a wooded area toward the town of Biesdorf. Pvt Poulter was killed by small arms fire as he approached the crest of a hill. His body could not be recovered due to intense fighting against heavily reinforced German forces in the area. In 1951, human remains were recovered in the woods where Pvt Poulter was killed. They could not be identified with the technology available at the time and were buried as an unknown. In September 2022, the Department of Defense and the American Battle Monuments Commission exhumed the remains for further study. The laboratory analysis and the totality of the circumstantial evidence available established an association between this set of remains and

On May 31, 2024 PVT Poulter remains arrived at the Indianapolis International Airport. Chapter Members, the Indiana Patriot Guard Riders, and guest met the PVT Poulter's procession in the cell phone parking lot. Upon arrival of the procession, the group joined in and rode to the Illinois State Line to the Cumberland Road Rest Stop located about 8 miles West of Terre Haute, IN. There we met up with Rolling Thunder® Illinois Chapter #3 and their guest. The procession then continued on to the funeral home located in Greenup, IL.

All along the route to the funeral home, the local community paid their respect to PVT Poulter by waving the American Flag and honoring the procession as it passed by. It was a great feeling to know that the American patriotism is still alive.

USS Harder (US 257)



US Submarine USS Harder was discovered on May 22, 2024 in 3,000 feet of water off the Philippine Islands by an exploration team led by Tim Taylor. USS Harder sank the most Japanese warships during WWII and vanished on August 24, 1944. 79 sailors were onboard to include two from Indiana.

There was no mentioning of remains being found aboard the Submarine. Hopefully, these two families may finally have some closure.

Origin of the 21-Gun Salute

The use of gun salutes for military occasions is traced to early warriors who demonstrated their peaceful intentions by placing their weapons in a position that rendered them ineffective. Apparently, this custom was universal, with the specific act varying with time and place, depending on the weapons being used. A North African tribe, for example, trailed the points of their spears on the ground to indicate that they did not mean to be hostile.

The tradition of rendering a salute by cannon originated in the 14th century as firearms and cannons came into use.



Since these early devices contained only one projectile, discharging them once rendered them ineffective. Originally warships fired seven-gun salutes--the number seven probably selected because of its astrological and Biblical significance. Seven planets had been identified and the phases of the moon changed every seven days. The Bible states that God rested on the seventh day after Creation, that every seventh year was sabbatical and that the seven times seventh year ushered in the Jubilee year.

Land batteries, having a greater supply of gunpowder, were able to fire three guns for every shot fired afloat, hence the salute by shore batteries was 21 guns. The multiple of three probably was chosen because of the mystical significance of the number three in many ancient civilizations. Early gunpowder, composed mainly of sodium nitrate, spoiled easily at sea, but could be kept cooler and drier in land magazines. When potassium nitrate improved the quality of gunpowder, ships at sea adopted the salute of 21 guns.

The 21-gun salute became the highest honor a nation rendered. Varying customs among the maritime powers led to confusion in saluting and return of salutes. Great Britain, the world's preeminent sea-power in the 18th and 19th centuries, compelled weaker nations to salute first, and for a time monarchies received more guns than did republics. Eventually, by agreement, the international salute was established at 21 guns, although the United States did not agree on this procedure until August 1875.

The gun salute system of the United States has changed considerably over the years. In 1810, the "national salute" was defined by the War Department as equal to the number of states in the Union--at that time 17.

This salute was fired by all U.S. military installations at 1:00 p.m. (later at noon) on Independence Day. The President also received a salute equal to the number of states whenever he visited a military installation.

In 1842, the Presidential salute was formally established at 21 guns. In 1890, regulations designated the "national salute" as 21 guns and redesignated the traditional Independence Day salute, the "Salute to the Union," equal to the number of states. Fifty guns are also fired on all military installations equipped to do so at the close of the day of the funeral of a President, ex-President, or President-elect.

Today the national salute of 21 guns is fired in honor of a national flag, the sovereign or chief of state of a foreign nation, a member of a reigning royal family, and the President, ex-President and President-elect of the United States. It is also fired at noon of the day of the funeral of a President, ex-President, or President-elect.

Gun salutes are also rendered to other military and civilian leaders of this and other nations. The number of guns is based on their protocol rank. These salutes are always in odd numbers.

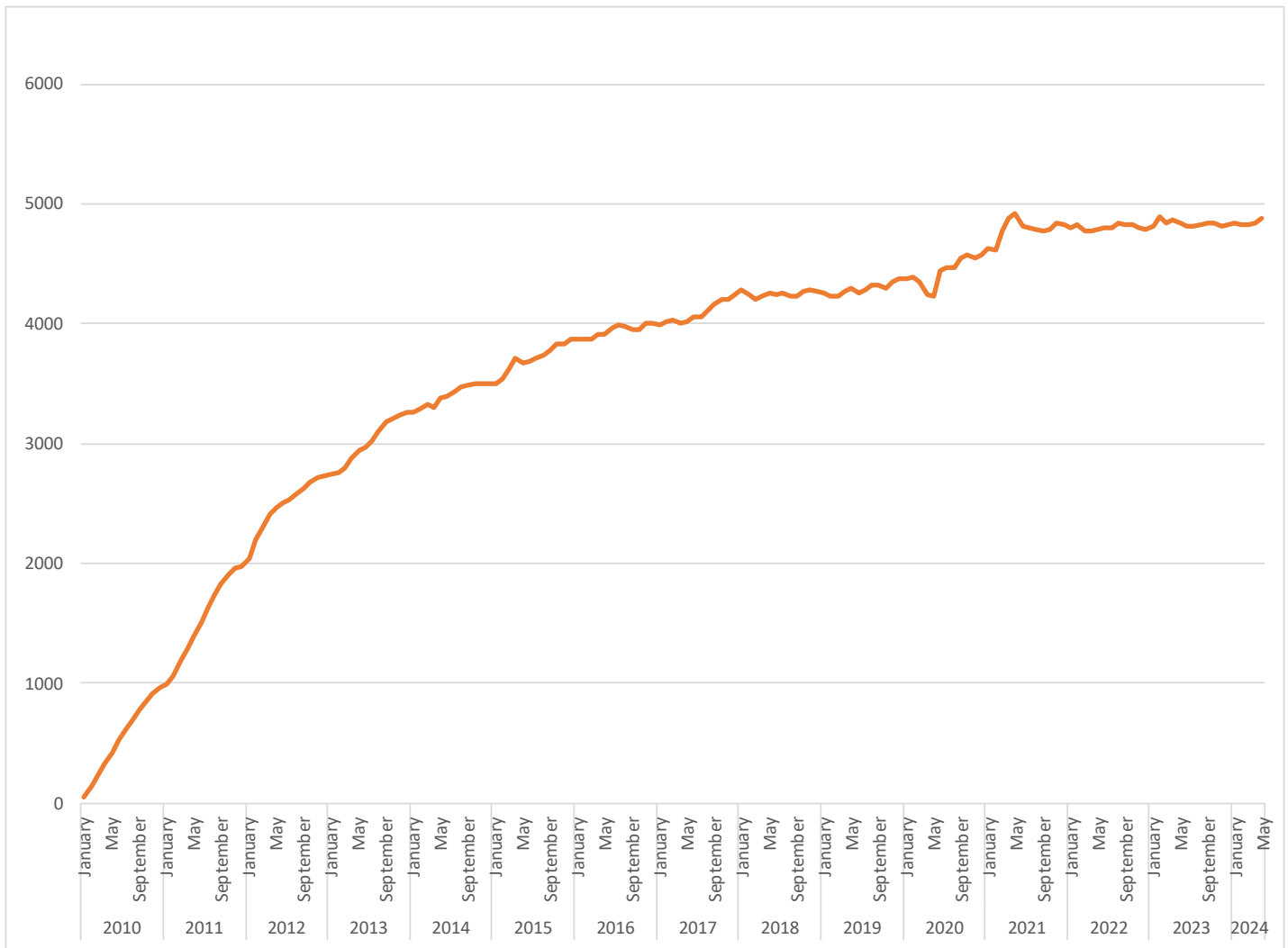

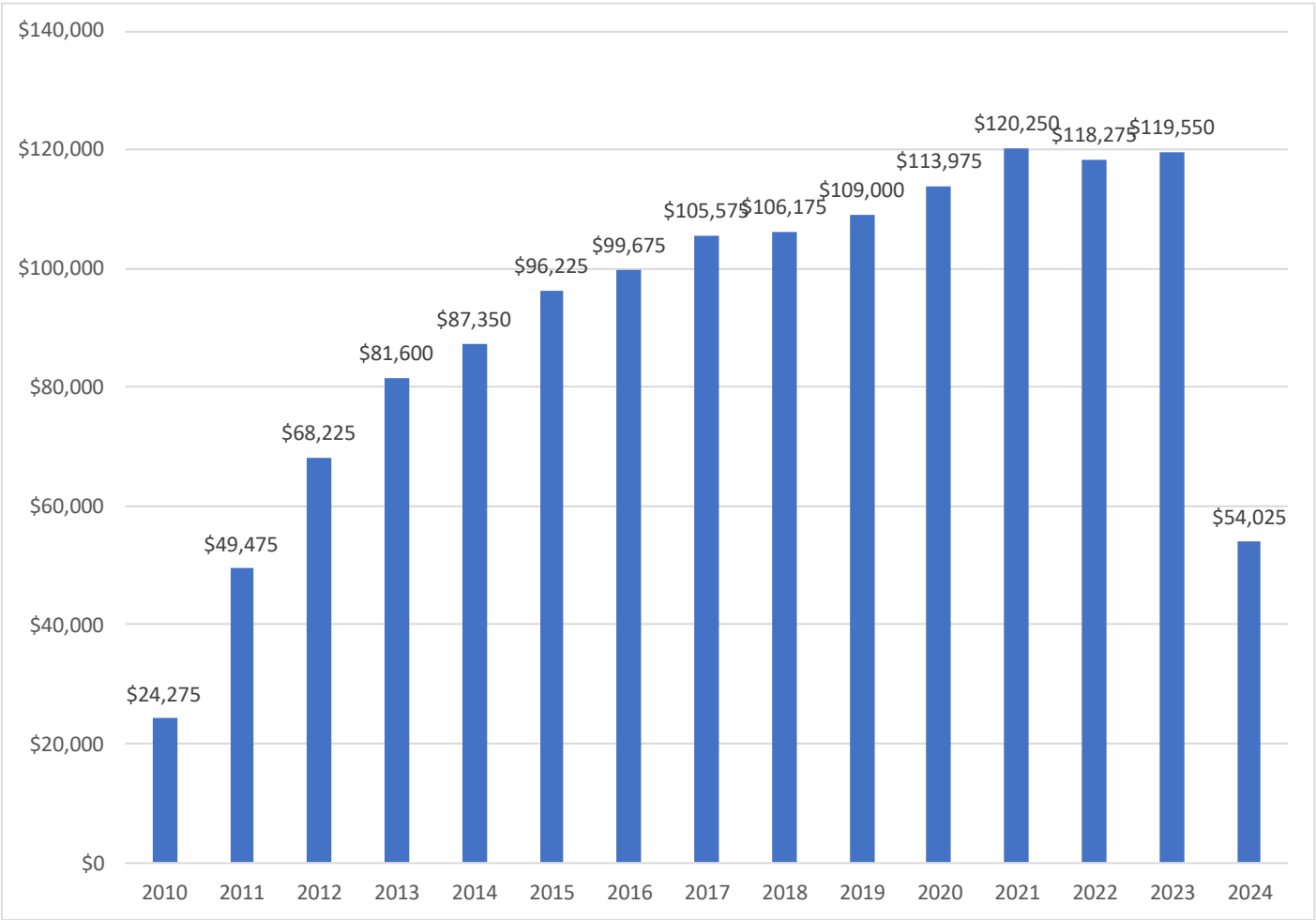
Indiana POW/MIA Specialty Plates on the Streets

As of May 31, 2024



As of May, 2024, we have **4,879** POW/MIA specialty plates on the streets of Indiana helping to bring awareness to the public about our POWs, and MIAs. The funds generated from the sale of the POW/MIA Specialty plate goes towards helping our Indiana Veterans in need through the Indiana Military Family Relief Fund (MFRF). **We are 39 plates up from this time last year.**

Indiana POW/MIA Specialty Plate Fund



Since the introduction of the Indiana POW/MIA Specialty Plate in January 2010, the plate has generated an estimated **\$1,353.650** 100% of the proceeds generated from the sales of the POW/MIA specialty plate goes to the Indiana Military Family Relief Fund (MFRF) to help our Indiana Veterans in need.

Rolling Thunder®, Inc. Membership Patches and Obligations

National Constitution

The Rolling Thunder® patches are items that members strive to obtain. The Boot patch represents the members Chapter, and the Rocker and Eagle represents Rolling Thunder® National. These patches should be worn proudly and with respect. When a member is issued these patches, they have an obligation to take care of them and turn them in if they decide to quit Rolling Thunder® for whatever reason. Below is an abstract from the National Constitution on the members obligations that they agree to when they receive these patches.



The Chapter Boot Patch. All members will receive a Rolling Thunder® Membership Boot patch when they become a full member at the end of a 120-day period. If a member meets his/her obligations before the 120 days are up they are entitled to receive their Boot patch no earlier than 90 days, provided they meet all other (loyalty and conduct) requirements. A new member must make 3 meetings or events, or a combination thereof, during the 120-day trial period to become a full member. **A \$50.00 patch deposit is required before National will issue the Boot Patch.**



The Rocker and Eagle Patches. After a member completes his/her first year (from the day they receive their boot patch) as a member in good standing, they will be issued the Eagle & Rocker patches, **which is the property of National.** **A \$100.00 patch deposit is required before National will issue the Rocker and Eagle Patches.**

Membership Obligations

Retrieve Patches: It's the Chapters responsibility to retrieve all patches. If a member does not renew dues in a reasonable time, thirty days from the end of February the Chapter President or his appointed representative will collect their patches. Any Chapter that does not retrieve the members patches will be held liable for their cost. Any problems from a delinquent member to collect our property, if needed have a lawyer send a letter and take them to court (quote the constitution) that a member will pay all court and lawyers fees. **The Chapter will pay National \$150.00 per set lost and members deposit will not be refunded.**

If you mail your patches to the Chapter, make sure you send the package CERTIFIED or PRIORITY mail for tracking purposes and insure the package for \$150.00.

Please DO NOT Glue your patches on your vest. National will NOT accept damaged patches and you may lose your patch refund.
