




INDY Honor Flight #43 September 14th

Saluting Branches at the Indiana Veterans Home September 18th

O 'dark early on Wednesday morning, Chapter members gathered at the Indiana Veterans Home in Lafayette Indiana to participate in the annual Saluting Branches event. Saluting Branches is a National event that takes place throughout the United States. Their Mission is to honor American service men and women by organizing volunteer tree and landscape care for the property dedicated to our veterans. In 2024, Saluting Branches serviced over 100 properties and had over 4,500 arborists volunteers.

The Chapter was invited to come and perform the Roll Call ceremony for our 51 that are still missing from the Vietnam War. As the name of the MIA was called, an arborists would place a helmet at the base of one of the 51 trees located in the Grove of Honor.

After the opening ceremony, the arborists went to work on the grounds of the Indiana Veterans Home.













Watch Fire Ceremony September 19th

The Watchfire is centuries old and had its origins in our country during the American Revolutionary War for independence. It is symbolic as a beacon, a guiding light for those service members who did not return home. It burns brightly so their spirits may see this light and know the love and respect we carry in our hearts for their sacrifice. The flame is an eternal symbol of our collective memory as a nation, born from ideals of freedom and honor. It calls us to solemn attention to the work before us on this evening of remembrance. As we reverently and proudly voice the name of each service member, let us maintain order and quiet reverence as a message of our grateful appreciation for their great personal sacrifice and devotion to the future of our nation.

The Indianapolis POW/MIA Council and Rolling Thunder® Indiana Chapter #1 conducted a Watch Fire ceremony at the Indiana War Memorial. The program included placing over 1,700 American Flags on the lawn of the Indiana War Memorial (IWM). These 1,700 flags represents the 1.700 Indiana Service Members that are still unaccounted for since WWII.

Youth groups toured the IWM and stopped at each period of War from the Revolutionary War to the Global War on Terror. There were Docents at each station to talk about that period of war and how Indiana was involved in the war. It was a great opportunity for the youths to learn more about each war and Indiana's involvement. The names of the 1,700 Indiana MIAs were read by the youth groups to honor, and remember them so they are not forgotten.

WWII MIA PFC Clossie Brown Frankfort Indiana



On April 24, 2024, the Defense POW/MIA Accounting Agency (DPAA) identified the remains of Private First Class Clossie D. Brown, missing from World War II. Private First Class Brown entered the U.S. Army in Indiana and served in Company F, 2nd Battalion, 157th Infantry Regiment, 45th Infantry Division. On January 21, he was on the front line of an attack on an enemy position near Reipertswiller, France. PFC Brown was pinned down by heavy sniper and machine gun fire that caused his unit to pull back. When the company regrouped, PFC Brown was reported as missing, but the exact circumstances of his loss are unknown.

On September 20th, the Indiana Patriot Guard and Chapter members escorted PFC Brown's remains from the Indianapolis Airport to the Goodwin's Funeral Home in Frankfort Indiana.

On September 24th, Chapter Members attended PFC Brown's funeral services at the Goodwin's Funeral Home in Frankfort Indiana. Upon the completion of the funeral services, Chapter Members, Patriot Guard, and VFW riders escorted PFC Brown to his final resting place at the Whiteman Cemetery located in Michigantown Indiana where he was buried with full Military Honors.

Indiana has 1,498 Indiana Service Members that are still unaccounted for from WWII.



















Taylor Kiland Briefing September 21st



Ms. Taylor Kiland came to the Fort Harrison Veterans Center to brief the membership on her book 'Unwavering'. The book is about the wives who fought to ensure no man is left behind. When some of America's military men are captured or go missing during the Vietnam War, a small group of military wives become their champions. Never had families taken on diplomatic roles during wartime, nor had the fate of our POWs and missing men been a nationwide concern. In cinematic detail, the book will plunge you directly into the political maneuvering the women navigated, onto the international stage they shared with world leaders, and through the landmark legacy they created.

She also coauthored the book "Lesions from the Hanoi Hilton". This book presents six principles practiced within the POW organizational culture that can be used to develop high-performance teams everywhere. The authors offer examples from both the POWs' time in captivity and their later professional lives that identify, in real-life situations, the characteristics necessary for sustainable, high-performance teamwork. The book takes readers inside the mind of James Stockdale, a fighter pilot with a degree in philosophy, who was the senior ranking officer at the Hanoi prison.

The theories Stockdale practiced become readily understandable in this book. Drawing parallels between Stockdale's guiding philosophies from the Stoic Epictetus and the principles of modern sports psychology, Peter Fretwell and Taylor Baldwin Kiland show readers how to apply these principles to their own organizations and create a culture with staying power. Originally intending their book to focus on Stockdale's leadership style, the authors found that his approach toward completing a mission was to assure that it could be accomplished without him. Stockdale, they explain, had created a mission-centric organization, not a leader-centric organization. He had understood that a truly sustainable culture must not be dependent on a single individual. At one level, this book is a business school case study. It is also an examination of how leadership and organizational principles employed in the crucible of a Hanoi prison align with today's sports psychology and modern psychological theories and therapies, as well as the training principles used by Olympic athletes and Navy SEALs. Any group willing to apply these principles can move their mission forward and create a culture with staying power—one that outlives individual members.


Pets Healing Vets Fundraiser October 5, 2024

An estimated 22 veterans commit suicide each day while approximately 2.7 million animals are euthanized in shelters every year. The main mission of the Pets Healing Vets program is to improve the emotional well-being of Hoosier veterans suffering from Post-Traumatic Stress Disorder (PTSD) or Traumatic Brain Injury (TBI) by pairing them with carefully selected shelter animals in need of homes.

The proceeds from the fundraiser will help the program to provide those Veterans in need of a pet to help them deal with their PTSD and TBI.

Special Thanks goes to Don Leasure for coordinating this special event. Don reports that the event had 39 motorcycles, 48 people in attendance, and generated over \$6,000 in donations for the Pets Healing Vets program. Great job.

Sergeant Alvin York Medal of Honor Winner

Alvin Cullum York (December 13, 1887 – September 2, 1964), also known by his rank as Sergeant York, was an American soldier who was one of the most decorated United States Army soldiers of World War I. He received the Medal of Honor for leading an attack on a German machine gun nest, gathering 35 machine guns, killing at least 25 enemy soldiers and capturing 132 prisoners. York's Medal of Honor action occurred during the United States-led portion of the Meuse–Argonne offensive in France, which was intended to breach the Hindenburg line and force the Germans to surrender. He earned decorations from several allied countries during the war, including France, Italy and Montenegro.



York was born in rural Tennessee, in what is now the community of Pall Mall in Fentress County. His parents farmed, and his father also worked as a blacksmith. The eleven York children had minimal schooling because they helped provide for the family, including hunting, fishing, and working as laborers. After the death of his father, York assisted in caring for his younger siblings and found work as a blacksmith. Despite being a regular churchgoer, York also drank heavily and was prone to fistfights. After a 1914 conversion experience, he vowed to improve and became even more devoted to the Church of Christ in Christian Union. York was drafted during World War I; he initially claimed conscientious objector status on the grounds that his religious denomination forbade violence. Persuaded that his religion was not incompatible with military service, York joined the 82nd Division as an infantry private and went to France in 1918.

In October 1918, Private First Class (Acting Corporal) York was one of a group of seventeen soldiers assigned to infiltrate German lines and silence a machine gun position. After the American patrol had captured a large group of enemy soldiers, German small arms fire killed six Americans and wounded three. Several of the Americans returned fire while others guarded the prisoners.

York and the other Americans attacked the machine gun position, killing several German soldiers. The German officer responsible for the machine gun position had emptied his pistol while firing at York but failed to hit him. This officer then offered to surrender, and York accepted. York and his men marched back to their unit's command post with more than 130 prisoners.

York was later promoted to sergeant and was awarded the Distinguished Service Cross. An investigation resulted in the upgrading of the award to the Medal of Honor. York's feat made him a national hero and international celebrity among allied nations.


Wreath Across America



Indiana POW/MIA Specialty Plates on the Streets As of September 30, 2024



As of September 2024, we have **4,826** POW/MIA specialty plates on the streets of Indiana helping to bring awareness to the public about our POWs, and MIAs. The funds generated from the sale of the POW/MIA Specialty plate goes towards helping our Indiana Veterans in need through the Indiana Military Family Relief Fund (MFRF). **We are 18 plates down from this time last year**.

Indiana POW/MIA Specialty Plate Fund From 2010 to 2024



Since the introduction of the Indiana POW/MIA Specialty Plate in January 2010, the plate has generated an estimated \$1,398,250100% of the proceeds generated from the sales of the POW/MIA specialty plate goes to the Indiana Military Family Relief Fund (MFRF) to help our Indiana Veterans in need.

If you don't have a Indiana POW/MIA Specialty Plate on your vehicle, please let the Bureau Motor Vehicle (BMV) know that you would like to purchase a Rolling Thunder® sponsored POW/MIA specialty plate on your next renewal or new purchase.

With the purchase of a Indiana POW/MIA specialty plate, not only will you be instrumental in helping to bring awareness to the public about our POWs and MIAs, you will be helping our Indiana Veterans in need.

Rolling Thunder®, Inc. Membership Patches and Obligations National Constitution

The Rolling Thunder® patches are items that members strive to obtain. The Boot patch represents the members Chapter, and the Rocker and Eagle represents Rolling Thunder® National. These patches should be worn proudly and with respect. When a member is issued these patches, they have an obligation to take care of them and turn them in if they decide to quit Rolling Thunder® for whatever reason. Below is an abstract from the National Constitution on the members obligations that they agree to when they receive these patches.



The Chapter Boot Patch. All members will receive a Rolling Thunder® Membership Boot patch when they become a full member at the end of a 120-day period. If a member meets his/her obligations before the 120 days are up they are entitled to receive their Boot patch no earlier than 90 days, provided they meet all other (loyalty and conduct) requirements. A new member must make 3 meetings or events, or a combination thereof, during the 120-day trial period to become a full member. A \$50.00 patch deposit is required before National will issue the Boot Patch.



The Rocker and Eagle Patches. After a member completes his/her first year (from the day they receive their boot patch) as a member in good standing ,they will be issued the Eagle & Rocker patches, which is the property of National. A \$100.00 patch deposit is required before National will issue the Rocker and Eagle Patches.

Membership Obligations

Retrieve Patches: It's the Chapters responsibility to retrieve all patches. If a member does not renew dues in a reasonable time, thirty days from the end of February the Chapter President or his appointed representative will collect their patches. Any Chapter that does not retrieve the members patches will be held liable for their cost. Any problems from a delinquent member to collect our property, if needed have a lawyer send a letter and take them to court (quote the constitution) that a member will pay all court and lawyers fees. The Chapter will pay National \$150.00 per set lost and members deposit will not be refunded.

If you mail your patches to the Chapter, make sure you send the package **CERTIFIED** or **PRIORITY** mail for tracking purposes and insure the package for \$150.00.

Please DO NOT Glue your patches on your vest. National will NOT accept damaged patches and you may lose your patch refund.
